#### **SUMMARY**

A request has been received from Johnathan Murray (father) and Crystal Cain (mother) 425 Stoker Ave. Reno, NV 89503, to disinter and relocate the remains of Rylee Nicole Murray, their daughter, who died on March 2, 2014, in Carmichael, California. Disinterment will be from Mountain View Cemetery in Reno, Nevada. The deceased remains will be transferred to Sierra Hills Memorial Park in Sacramento, California to be interned with family. Mountain View Cemetery in Reno, Nevada will be in charge of all arrangements.

Nevada Revised Statute 451.050, Subsection 2 authorizes the Washoe Board of County Commissioners to grant permits for disinterments and removal of human remains, provided the death was not due to a communicable disease. The death certificate indicates that death was not due to a communicable disease.

#### FISCAL IMPACT

There will be no fiscal impact to Washoe County as the cost of the disinterment and removal will be borne by Johnathan Murray and Crystal Cain.
