Ms. Solorzano is currently the Accounting Manager in the Comptroller's Office and has been with Washoe County for 10 years.

PREVIOUS ACTION

On May 13, 2014 the Board of County Commissioners confirmed the appointment of Paul McArthur as the Comptroller effective June 10, 2014. Mr. McArthur submitted his resignation effective May 1, 2015.

BACKGROUND

The Board is asked to confirm the appointment of Mary Solorzano as Interim Comptroller effective May 4, 2015 until the Comptroller recruitment process has concluded and the position is filled. Ms. Solorzano is currently the Accounting Manager in the Comptroller's Office and has been with Washoe County for 10 years.

On May 13, 2014 the Board of County Commissioners confirmed the appointment of Paul McArthur as the Comptroller effective June 10, 2014. Mr. McArthur submitted his resignation effective May 1, 2015.

Based on operational and statutory requirements, County Manager Slaughter appointed Mary Solorzano as Interim Comptroller effective May 4, 2015. The Department of Human Resources has initiated a national recruitment effort for a permanent Comptroller. Once that process has concluded this item will be brought back to the Board for confirmation of the appointed candidate.
