The Board met pursuant to recess taken March 4th and transacted the following business,
to-wit:-

COUNTY STATE HIGHWAY

The Board of County Commissioners met with S. C. Durkee, State Highway Engineer and requested permission to use \$25,000.00 of County-State Highway Funds for the improvement of the Mt. Rose Road, the permission was granted.

State Highway Engineer requested that the Board of County Commissioners allow the Highway Department the sum of \$7,000.00 to repair the State Highway at Chalk Bluff and to erect the retaining wall, permission was granted.

TRUCKS FOR ROAD DEPARTMENT.

On motion duly seconded and carried by the unanimous vote of the board, it was ordered that the bid of the Reno-Hudson-Essex Incorporated to furnish an International Truck for the sum of \$3219.30, be and the same is hereby accepted; that the bid of Jake Wainwright for one Sterling Truck for \$2559.25, two yard capacity with a hand hoist, be and the same is hereby accepted; that the bid of the Osen Motor Sales Company for one Dodge Truck, three yard capacity, hydraulic body, for \$2970.00, be and the same is hereby accepted.

AUTOMOBILE FOR SHERIFF'S OFFICE.

On motion duly seconded and carried by the unanimous vote of the board, it was ordered that the Clerk advertise for bids for a coupe or sedan for the use of the traffic department for the Sheriff's office, the roadster now in use to be turned in on the purchase.

SPECIAL ORDINANCE
FOR CLOSED SEASON FOR FISHING ON TRUCKEE RIVER

On motion duly seconded and carried by the unanimous vote of the board, it was ordered that the following ordinance be adopted and that the same be published in the Nevada State Journal once a week for four weeks:-

SPECIAL ORDINANCE.

AN ORDINANCE EXTENDING THE CLOSED SEASON FOR FISHING IN THE TRUCKEE RIVER BETWEEN THE WEST BOUNDARY OF IDLEWILD PARK AND THE GLENDALE BRIDGE IN WASHOE COUNTY, NEVADA, UNTIL THE FIRST DAY OF OCTOBER, 1929.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY, NEVADA, DO ORDAIN:

SECTION 1. The closed season for fishing in the Truckee River between the west boundary of Idlewild Park and the Glendale Bridge in Washoe County, Nevada, is hereby extended until the first day of October, 1929.

SEC. 2. Said closed season for said portion of the Truckee River as provided in Section 1 hereof, is hereby declared, in the opinion of the said Board of County Commissioners of Washoe County, Nevada, to be required for the protection of the fish in said portion of said Truckee River, to the end that the supply of fish for food may be permanently increased, said portion of said Truckee River having been stocked with food fish by the State of Nevada and its Fish Commissioners.

SEC. 3. This ordinance shall be effective from and after its passage and publication once a week for four (4) consecutive weeks.

SEC. 4. Any person who shall violate the provisions of this ordinance shall be guilty of a misdemeanor, and shall be fined not less than fifty (\$50.00) dollars nor more than two hundred and fifty (\$250.00) dollars, or imprisoned in the county jail not less than twenty-five (25) days nor more than one hundred and twenty-five (125) days, or by both such fine and imprisonment, in the discretion of the Court.

SEC. 5. The County Clerk and Clerk of the Board of County Commissioners of Washoe County, Nevada, is hereby authorized and directed to have this ordinance published once a week for four (4) consecutive weeks in the Nevada State Journal, a newspaper published and of general circulation in Washoe County, Nevada, and to also post a copy of this ordinance in at least four (4) conspicuous places along the side of the Truckee River between the west boundary of Idlewild Park and the Glendale Bridge in Washoe County, Nevada.
