WASHINGTON HEIGHTS SUBDIVISION.

On motion duly seconded and carried by the unanimous vote of the board, <sup>present,</sup> it was ordered that the Board of County Commissioners sign a deed to the following described real estate:

All that portion of Lot 7 in Block B as shown on the official map of Blocks A, B, C, D, E, F, G and H of WASHINGTON HEIGHTS SUBDIVISION NO. 1, Washoe County, Nevada, filed in the office of the county recorder of Washoe County, State of Nevada, on June 23, 1942, which was included within the parcel of land conveyed for street purposes in the deed dated October 28, 1940, recorded in Book 135 of Deeds, page 344, Washoe County Records, and executed by J. N. Evans incorporated, a Nevada corporation to the said County of Washoe, State of Nevada.

ORDINANCE.REGULATING SPEED ON RENO-PURDY HIGHWAY.

On motion duly seconded and carried by the unanimous vote of the board present, it was ordered that the following ordinance be adopted and spread in full upon the minutes:

COUNTY ORDINANCE.

An Ordinance to Regulate Traffic on the Reno Purdy Highway between State Line and North City Limits of Reno, making the violation thereof a misdemeanor, and other matters properly connected therewith.

The Board of County Commissioners of the County of Washoe, Nevada, do Ordain:

Section 1. The speed of any vehicle upon the Reno-Purdy Highway between State Line and the North City Limits of Reno, in excess of 35 miles per hour is prima facie evidence of the operation of a vehicle on said highway in a reckless manner, at a rate of speed greater than is reasonable and proper, having due regard for the traffic, surface and width of the highway and is unlawful and a misdemeanor unless the driver or the one legally responsible for the operation of such vehicle establishes by competent evidence that said speed in excess of 35 miles per hour did not constitute a violation of Section 4350 Nevada Compiled Laws, 1929, as amended, at the time, place, and under the conditions then existing.

Section 2. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.
