 PRESCRIBING A PENALTY FOR THE VIOLATION  
 THEREOF, AND OTHER MATTERS RELATING THERETO."

 STATE OF NEVADA, DO ORDAIN:

SECTION 1. Section 3 of the above-entitled ordinance is  
 hereby amended to read as follows:

16 SECTION 2. The above-entitled ordinance is hereby amended  
 17 by the addition of a new section to be known as Section 3a which  
 18 shall read as follows:

19 SECTION 3a. The applicant or applicants for a building  
 20 permit shall at the time of filing an application for said  
 21 permit pay to the County of Washoe for expense of inspection and  
 22 examination of the building and plans and specifications thereof  
 23 a fee based upon the following total valuations:

25	Less than \$20.00	- - - - -	No fee
25	\$20.00 to and including \$100.00	- - - - -	.50
26	More than \$100.00 to and including \$400.00	- - - - -	1.00
26	More than \$400.00 to and including \$700.00	- - - - -	1.50
27	More than \$700.00 to and including \$1,000.00	- - - - -	2.00
27	Each additional \$1,000.00 or fraction, to and including \$15,000.00	- - - - -	1.00
28	Each additional \$1,000.00 or fraction, to and including \$50,000.00	- - - - -	.50
29	Each additional \$1,000.00 or fraction exceeding \$50,000.00	- - - - -	.25

1           SECTION 3. The above-entitled ordinance is hereby amended  
2 by the addition of a new section to be known as Section 3b which  
3 shall read as follows:

4           SECTION 3b. Any permit which may be issued pursuant to the  
5 provisions of this ordinance under which the work authorized is  
6 not commenced within one year from the time of issuance shall  
7 expire and thereafter be of no force and effect; provided, how-  
8 ever, that once work is commenced as authorized in any permit it  
9 shall thereafter be prosecuted diligently to completion and fail-  
10 ure of a permittee to so diligently prosecute such work to com-  
11 pletion shall be ground for revocation of said permit.

12           SECTION 4. All ordinances and parts of ordinances in con-  
13 flict with this ordinance are hereby expressly repealed.

14           SECTION 5. This ordinance shall be in full force and effect  
15 from and after its passage and approval.
