In accordance with Chapter 296 of the 1955 statutes of the State of Nevada, NOTICE is hereby given that AN ORDINANCE TO ESTABLISH A SPEED LIMIT ON SOUTH VERDI HIGHWAY COMMENCING AT THE INTERSECTION OF HUNTER LAKE DRIVE OF THE CITY OF RENO WEST U. S. HIGHWAY 40, IN WASHOE COUNTY, NEVADA; PROVIDING THE PENALTY FOR VIOLATION THEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO, was proposed on August 20th, 1955 by Commissioner E. J. Kleppe; final action of adoption taken on September 6th, 1955 by the following vote:

5 AN ORDINANCE ESTABLISHING A SPEED LIMIT ON SOUTH  
6 VERDI HIGHWAY COMMENCING AT THE INTERSECTION OF  
7 HUNTER LAKE DRIVE OF THE CITY OF RENO WEST U.S.  
8 HIGHWAY 40 IN WASHOE COUNTY, NEVADA; PROVIDING  
9 THE PENALTY FOR VIOLATION THEREOF; AND OTHER  
10 MATTERS PROPERLY RELATING THERETO.

11 THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE  
12 DO ORDAIN:

13 SECTION 1: That on South Verdi Highway, commencing at the inter-  
14 section of Hunter Lake Drive of the City of Reno west to U. S.  
15 Highway 40 in Washoe County, Nevada, the maximum speed limit for  
16 all motor vehicles is hereby established at thirty-five (35)  
17 miles per hour.

18 SECTION 2: Any person who drives, propels, operates or conducts  
19 any motor vehicle on said South Verdi Highway within said area at  
20 a rate of speed exceeding thirty-five (35) miles per hour shall  
21 be guilty of a misdemeanor and shall be punished by a fine not  
22 exceeding Five Hundred (\$500.00) Dollars or imprisonment in the  
23 County Jail in Washoe County, Nevada, not exceeding six (6) months  
24 or by both such fine and imprisonment.
