NOTICE OF COUNTY ORDINANCE

Notice is hereby given that Bill No. 398, Ordinance No. 240, entitled "An Ordinance requiring the issuance of a health permit prior to the operation of any ambulance or air-ambulance service within the Washoe County Health District and requiring the issuance of a license to any person acting in the capacity of an attendant, air-attendant or volunteer of any ambulance or air-ambulance service operating in the Washoe County Health District; and approving the schedule of fees to be collected by the Washoe County District Health Officer to defray the costs and expenses of the permit and licensing procedures set forth in the "regulations of the Washoe County District Board of Health governing permits and operation of ambulances and air-ambulances and licensure of attendants and air-attendants within Washoe County, Nevada", was adopted on October 7, 1974 by Commissioners Rusk, Nelson, Pagni, Crow and Scott all voting aye.

Summary: An Ordinance Requiring the Issuance of Health Permits and Licenses by Washoe County District Health Officer Prior to the Operation of Any Ambulance or Air-Ambulance in the Washoe County Health District and Approving the Schedule of Fees Therefor.

ORDINANCE NO. 240

AN ORDINANCE REQUIRING THE ISSUANCE OF A HEALTH PERMIT PRIOR TO THE OPERATION OF ANY AMBULANCE OR AIR-AMBULANCE SERVICE WITHIN THE WASHOE COUNTY HEALTH DISTRICT AND REQUIRING THE ISSUANCE OF A LICENSE TO ANY PERSON ACTING IN THE CAPACITY OF AN ATTENDANT, AIR-ATTENDANT OR VOLUNTEER OF ANY AMBULANCE OR AIR-AMBULANCE SERVICE OPERATING IN THE WASHOE COUNTY HEALTH DISTRICT; AND APPROVING THE SCHEDULE OF FEES TO BE COLLECTED BY THE WASHOE COUNTY DISTRICT HEALTH OFFICER TO DEFRAY THE COSTS AND EXPENSES OF THE PERMIT AND LICENSING PROCEDURES SET FORTH IN THE "REGULATIONS OF THE WASHOE COUNTY DISTRICT BOARD OF HEALTH GOVERNING PERMITS AND OPERATION OF AMBULANCES AND AIR-AMBULANCES AND LICENSURE OF ATTENDANTS AND AIR-ATTENDANTS WITHIN WASHOE COUNTY, NEVADA"

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1. Permit Requirement.

No person, either as owner, agent or otherwise, shall furnish, operate, conduct, maintain, advertise or otherwise be engaged in, or profess to be engaged in, the business, service or volunteer service of the transportation of patients upon the streets, roads, alleys, highways or any public way or airway within the Washoe County Health District, unless he holds a currently valid permit to operate an ambulance service or volunteer service either issued by the Washoe County District Health Officer pursuant to the "Regulations of the Washoe County District Board of Health Governing Permits and Operation of Ambulances and Air-ambulances and Licensure of Attendants and Air-attendants within Washoe County, Nevada" or issued by the Health Division of the Nevada State Department of Human Resources, or unless such person is excepted from the permit requirements contained in the aforesaid health Regulations.

Section 2. License Requirement.

No person shall act in the capacity of an attendant, air-attendant or volunteer of an ambulance or air-ambulance service or volunteer service within the meaning of the "Regulations of the Washoe County District Board of Health Governing Permits and Operation of Ambulances and Air-ambulances and Licensure of Attendants and Air-attendants within Washoe County, Nevada," unless such person holds and carries on his person a currently valid license to act in such capacity either issued by the Washoe County District Health Officer in accordance with the aforesaid Regulations or issued by the Health Division of the Nevada State Department of Human Resources, or unless such person is excepted from the license requirements contained in the aforesaid health Regulations.

Section 3. Schedule of Fees.

The schedule of fees set forth in the Regulations of the Washoe County District Board of Health referred to in Sections 1 & 2



above for the issuance and renewal of permits and licenses as required therein have been reviewed and are hereby approved; and the Washoe County District Health Officer shall collect such fees for the purposes and in the manner set forth in said Regulations. Such fees shall be used for the sole purpose of defraying the costs and expenses of the permit and licensing procedures and investigations related thereto as required and permitted under the aforesaid Regulations.

Section 4. Penalties.

Any person who violates any of the provisions of the permit or license requirements of the Regulations of the Washoe County District Board of Health referred to in Sections 1 & 2 above shall be deemed guilty of a misdemeanor within the meaning of NRS 439.580 and shall be subject to the usual penalties for such offense as provided in the Nevada Revised Statutes. Nothing contained herein shall prohibit the enforcement of any other penalties or remedies for any other violations as provided for in said Regulations.

Section 5. Validity of Remainder of Ordinance.

If any provision or part of this Ordinance or any of the Regulations referred to herein shall be declared by a court of competent jurisdiction to be illegal in any manner or form, it shall in no way affect the remainder of this Ordinance or any section thereof or Regulation incorporated herein by reference, it being intended that the remainder shall remain in full force and effect.

Section 6. Other Licensing Ordinances.

Nothing contained herein shall repeal, invalidate or render inoperative the requirements of any other licensing ordinance of the County of Washoe applicable to the operation of an ambulance or air-ambulance service business.

Section 7. Effective Date.

This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.





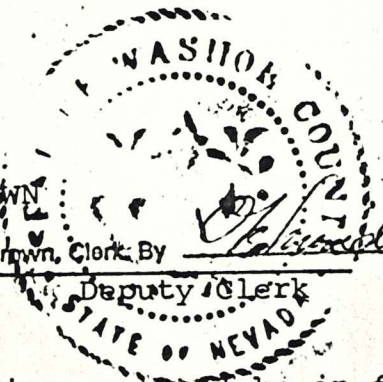
