SUMMARY: Amends Washoe County Ordinance No. 179 by defining "Caucus Meetings" and establishing regular meeting dates for caucus meetings, and amending the title thereto.

BILL NO. 416

ORDINANCE NO. 253

AN ORDINANCE AMENDING WASHOE COUNTY ORDINANCE NO. 179 ENTITLED, "AN ORDINANCE ESTABLISHING THE 5TH, 15TH AND 25TH DAY OF EACH AND EVERY MONTH AS THE REGULAR MEETING DATES OF THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY, AND OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Washoe County Ordinance No. 179 is hereby amended by adding the following Section thereto:

SECTION 2. Caucus Meetings, Defined.

A caucus meeting is a meeting of the Board of County Commissioners held for the purpose of discussing matters which will appear on the agenda of the next following regular meeting, and also to discuss other matters which may be brought to the attention of the Board. Caucus meetings shall be held for the purpose of discussion only, and action by the Board of County Commissioners shall be taken only in regular meetings, or special meetings held pursuant to the provisions of NRS 244.090.

SECTION 2.

Washoe County Ordinance No. 179 is hereby amended by adding the following Section thereto:

SECTION 3. Caucus Meetings.

The caucus meetings of the Board of County Commissioners of Washoe County shall be held at Reno, Washoe County, Nevada on the first judicial day preceding each regular meeting.

SECTION 3.

The title of Washoe County Ordinance No. 179 is hereby amended to read as follows:

AN ORDINANCE ESTABLISHING REGULAR MEETING DATES OF THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY, DEFINING CAUCUS MEETINGS, ESTABLISHING CAUCUS MEETING DATES, AND OTHER MATTERS PROPERLY RELATED THERETO.

SECTION 4.

This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
