SUMMARY: Amends Washoe County Ordinance No. 116 to provide for annual election of officers of the Washoe County Park Commission and deletion of necessity for offices of secretary and treasurer after January, 1976.

BILL NO. 447

ORDINANCE NO. 283

AN ORDINANCE CREATING A COUNTY PARK COMMISSION, DESIGNATING A NAME FOR THE COMMISSION, ESTABLISHING THE POWERS OF THE COMMISSION, DESIGNATING THE FACILITIES FOR WHICH THE COMMISSION SHALL BE RESPONSIBLE, SETTING FORTH THE NAMES OF THE SIX APPOINTED COMMISSIONERS WHO SHALL SERVE ON THE FIRST COUNTY PARK COMMISSION AND STATING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Section 8(b) of Washoe County Ordinance No. 116 is hereby amended to read as follows:

- (b) Within ten (10) days after their appointment, the commissioners shall organize as the commission by the election of one of their members as chairman and one as secretary and by the election of such other officers as they may deem necessary. The commissioners shall elect a chairman, vice-chairman and such other officers as are necessary from among their members during the first regularly scheduled meeting of the commission in the month of January, 1976 and annually thereafter at the first regularly scheduled meeting in the month of January.

SECTION 2.

This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
