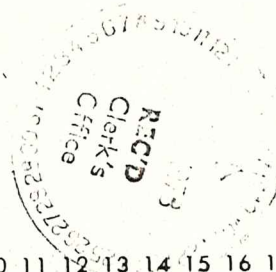

SUMMARY: Adopts standard specifications for public works construction.

BILL NO. 569

ORDINANCE NO. 401

AN ORDINANCE ADOPTING THE 1978 EDITION OF THE STANDARD SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION SPONSORED BY WASHOE AND DOUGLAS COUNTIES, THE CITIES OF RENO AND SPARKS AND CARSON CITY; DEFINING WORDS AND TERMS; PROVIDING SPECIFICATIONS FOR CONSTRUCTION MATERIALS AND METHODS; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1. Definitions. As used in this ordinance:

1. "Person" includes a company, partnership, association or corporation as well as a natural person.

2. "Standard Specifications for Public Works Construction" means the 1978 Edition of the Standard Specifications for Public Works Construction sponsored, prepared and published by Washoe and Douglas Counties, the Cities of Reno and Sparks and Carson City, Nevada.

Sec. 2. Standard Specifications for Public Works Construction; Adoption; penalty.

1. The Standard Specifications for Public Works Construction, a copy of which has been placed on file in the office of the county clerk, is hereby adopted by reference, incorporated herein and made a part hereof, and shall regulate all matters contained therein.

2. Any person violating any of the provisions of subsection 1 is guilty of a misdemeanor, and each such person is guilty of a separate offense for each day or portion thereof during which any violation of any of the provisions of subsection 1 is committed, continued or permitted. Upon conviction of any such violation, such person shall be punished by a fine of not more than \$500 or by imprisonment in the county jail for not more than 6 months, or by both such fine and imprisonment.

Sec. 3. Effective date. This Ordinance shall be in full force and effect from and after its adoption pursuant to NRS 244.105.


