SUMMARY: An Ordinance establishing fees for recording maps of division into large parcels pursuant to Senate Bill 120, Session Laws of Nevada, 1979.

BILL NO. 622

ORDINANCE NO. 451

AN ORDINANCE TO ESTABLISH A UNIFORM FILING FEE FOR A NEW CATEGORY OF MAPS ENTITLED, "MAP OF DIVISION INTO LARGE PARCELS"; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

SECTION 1. Recording Fee for Map of Division into Large Parcels.

Any person required by law to file with the County Recorder a map of division into large parcels shall upon filing with the County Recorder pay for the recording of said map the amount of twenty-five (\$25.00) dollars for the first page of said map plus a fee of ten (\$10.00) dollars for each additional page thereof.

SECTION 2. Severability.

If any provision of this ordinance is declared by a court of competent jurisdiction to be illegal or unconstitutional, it shall in no way affect the remainder of this ordinance or any part thereof, and the remaining provisions of this ordinance shall remain in full force and effect.
