ORDINANCE NO. 476

AN ORDINANCE AMENDING "AN ORDINANCE CONCERNING THE ESTABLISHMENT, OPERATION, MAINTENANCE, ADVERTISEMENT AND REGULATION OF CHILD CARE FACILITIES; PROVIDING FOR THE ISSUANCE OF LICENSES AND PERMITS FOR THE OPERATION OF CHILD CARE FACILITIES; REQUIRING THE BUILDING INSPECTOR TO VISIT AND INSPECT PREMISES WHICH ARE TO BE USED FOR CHILD CARE FACILITIES; REQUIRING HEALTH DEPARTMENT INSPECTIONS AND FIRE INSPECTIONS OF CHILD CARE FACILITIES; PRESCRIBING PENALTIES FOR THE VIOLATION THEREOF; REPEALING WASHOE COUNTY ORDINANCE NO. 73; AND OTHER MATTERS PROPERLY RELATING THERETO" BY DESIGNATING THE WASHOE COUNTY WELFARE DEPARTMENT AS THE CHILD CARE LICENSING AGENCY OF WASHOE COUNTY.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. The title of Washoe County Ordinance No. 312 is hereby amended to read as follows:

AN ORDINANCE DESIGNATING THE WASHOE COUNTY WELFARE DEPARTMENT AS THE CHILD CARE LICENSING AGENCY OF WASHOE COUNTY.

SECTION 2. Section 1 of Washoe County Ordinance No. 312 is hereby amended to read as follows:

SECTION 1. The Washoe County Welfare Department is hereby designated as the Child Care Licensing Agency of Washoe County pursuant to subsection 2 of NRS 432A.131.

SECTION 3. Existing sections 2 to 26, inclusive, of Washoe County Ordinance No. 312 are hereby repealed.
