AN ORDINANCE REPEALING "AN ORDINANCE ESTABLISHING FEES FOR SOLEMNIZATION OF MARRIAGES BY THE OFFICE OF THE COMMISSIONER OF CIVIL MARRIAGES, AUTHORIZING THE HOURS OF OPERATION FOR THE OFFICE OF THE COMMISSIONER OF CIVIL MARRIAGES TO BE ESTABLISHED BY THE COMMISSIONERS, PROVIDING FOR PAYMENT OF SALARIES TO EMPLOYEES OF THE OFFICE OF THE COMMISSIONER OF CIVIL MARRIAGES AND MARRIAGE LICENSE BUREAU FOR SUNDAYS AND HOLIDAYS AT THE SAME RATE AS OTHER COUNTY EMPLOYEES, AND OTHER MATTERS PROPERLY RELATING THERETO."
