BILL NO. 787

ORDINANCE NO. 614

AN ORDINANCE AMENDING CHAPTER 70 OF THE WASHOE COUNTY CODE BY DESIGNATING A SPEED LIMIT FOR A PORTION OF CALLAHAN ROAD.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 70.350 of the Washoe County Code is hereby amended to read as follows:

70.350 Restricted speed zones: Geiger-Steamboat-Galena. Restricted speed zones are hereby established for the following public streets, roads and highways within the unincorporated area of the county with the maximum vehicular speeds allowable set opposite the names of such public streets, roads and highways:

- Andrew Lane..... 25 m.p.h.
- Callahan Road..... 35 m.p.h.
- Unless otherwise posted as..... 25 m.p.h.
- Toll Road..... 45 m.p.h.
- Unless otherwise posted as..... 35 m.p.h.
