 PUBLIC NOTICE IS HEREBY GIVEN that Ordinance No. 823, Bill No. 998, "An ordinance amending the Washoe County Code by clarifying the prohibition on the use of a recreational vehicle for dwelling or sleeping purposes outside of a recreational vehicle park; and providing other matters properly relating thereto" was adopted on May 14, 1991, by Commissioners Larry Beck, Dianne Cornwall, Gene McDowell, and Rene Reid, and will become effective on May 27, 1991. SUMMARY: Amends Washoe County Code to clarify prohibition on use of recreational vehicle for dwelling or sleeping purposes outside of a recreational vehicle park.

BILL NO. 998

ORDINANCE NO. 823

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY CLARIFYING THE PROHIBITION ON THE USE OF A RECREATIONAL VEHICLE FOR DWELLING OR SLEEPING PURPOSES OUTSIDE OF A RECREATIONAL VEHICLE PARK; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. 120.560 of the Washoe County Code is hereby amended to read as follows:

120.560 Location outside parks or subdivisions.

1. Nothing in this chapter precludes the use of a recreational vehicle for dwelling or sleeping purposes outside a recreational vehicle park if all liquid and solid wastes from the vehicle are disposed of in accordance with law and regulations of the health division of the department of human resources and the Washoe County district health department and as long as the use is permitted under chapter 110.

2. Nothing in this chapter prohibits the storage of a recreational vehicle on the premises of its owner. In District No. 2, storage of a recreational vehicle is permitted only in commercial or industrial districts.

3. Storage or use of any mobile home outside a mobile home park or mobile home subdivision shall be governed by the provisions of this chapter, and any other applicable laws, ordinances or regulations.

4. The use of a recreational vehicle for dwelling or sleeping purposes is prohibited except as provided for in this chapter and in conjunction with the provisions of chapter 110.


