ORDINANCE NO. 837

AN ORDINANCE AMENDING CHAPTER 110 OF THE WASHOE COUNTY CODE BY PROVIDING COMPENSATION FOR WASHOE COUNTY PLANNING COMMISSIONERS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 110.0153 of the Washoe County Code is hereby amended to read as follows:

110.0153 Compensation. Each member of the Washoe County planning commission shall be entitled to receive the amount of \$50 per planning commission meeting at which he is in attendance, not to exceed \$100 in any given month. In addition, commissioners shall be entitled to reasonable travel and living expenses in accordance with Chapter 5 herein.
