THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:


SECTION 1. Section 3 of Washoe County Ordinance No. 865 is hereby amended to read as follows:

SECTION 3. With the exception of section 110.312.10(d), (f) and (g) of the Washoe County Code (section 110.312.10(d), (f) and (g) of the Washoe County Development Code), the provisions of this ordinance shall be in force and effect from and after the 26th day of May, 1993. The provisions of section 110.312.10(d), (f) and (g) of the Washoe County Code (section 110.312.10(d), (f) and (g) of the Washoe County Development Code), shall not be in force and effect unless and until a new ordinance is enacted by the board dealing with said section.


