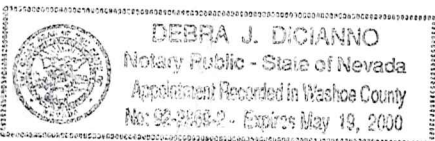

NOTICE IS HEREBY GIVEN THAT: Bill No. 1148 Ordinance No. 973, entitled AN ORDINANCE AMENDING ORDINANCE NO. 830, ARTICLE 6, OF THE UNIFORM SCHEDULE OF CHARGES FOR SEWER CONNECTION FEES IMPLEMENTING THE WATER QUALITY AGREEMENT BY IMPOSING A SURCHARGE WITHIN THE AREA OF WASHOE COUNTY WHICH RECEIVES SEWER TREATMENT SERVICE AT THE TRUCKEE MEADOWS WATER RECLAMATION FACILITY; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO, was adopted on JANUARY 14, 1997, by Commissioners Jim Galloway, Mike Mouliot, Jim Shaw, and Grant Sims, with Joanne Bond absent, and will become effective on JANUARY 31, 1997. ORDINANCE NO. 973

AN ORDINANCE AMENDING ORDINANCE NO. 830, ARTICLE 6, OF THE UNIFORM SCHEDULE OF CHARGES FOR SEWER CONNECTION FEES IMPLEMENTING THE WATER QUALITY AGREEMENT BY IMPOSING A SURCHARGE WITHIN THE AREA OF WASHOE COUNTY WHICH RECEIVES SEWER TREATMENT SERVICE AT THE TRUCKEE MEADOWS WATER RECLAMATION FACILITY; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1. Article 6 of Ordinance No. 830 is hereby amended by adding thereto a new Article 6.16 to read as follows:

6.16 Connection charge payable for certain portions of the unincorporated area of the county. In addition to the connection charges previously set forth in this article, there shall be a \$200.00 fee for each single family residential unit or equivalent dwelling unit [ERU] of one or greater within those portions of the unincorporated area of the county receiving sewer service at the Truckee Meadows Water Reclamation Facility.
