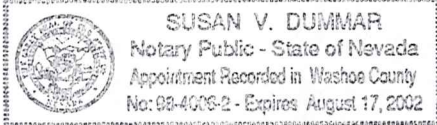

SUMMARY: Amends Washoe County Code by expanding the Spanish Springs congested area for purposes of dog control.

ORDINANCE NO. 1063

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY EXPANDING THE SPANISH SPRINGS CONGESTED AREA WITH RESPECT TO THE CONTROL OF DOGS AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 55.088 of the Washoe County Code is hereby amended to read as follows:

55.088 Spanish Springs area: Congested area. The Spanish Springs area is determined to be a congested area and is specifically described as: All of sections 23, 25, 26, 27, 34, 35, 36 and the E 1/2 of sections 22 and 33, T. 21 N., R. 20 E., M.D.B.&M., and the E 1/2 of section 4 and all of section 3 west of the westerly right-of-way line of Highway 33, T. 20 N., R. 20 E., M.D.B.&M., and the W 1/2 of the SW 1/4 of the NW 1/4 and the W 1/2 of the NW 1/4 of the SW 1/4 of section 30, T. 21 N., R. 21 E., M.D.B.&M.
