SUMMARY: An ordinance amending Washoe County Code by creating an account in the county general fund to be designated as the Account for the Acquisition and Improvement of Technology in the Office of the County Assessor.

ORDINANCE NO. 1300

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY CREATING AN ACCOUNT IN THE COUNTY GENERAL FUND TO BE DESIGNATED AS THE ACCOUNT FOR THE ACQUISITION AND IMPROVEMENT OF TECHNOLOGY IN THE OFFICE OF THE COUNTY ASSESSOR AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 15 of the Washoe County Code is hereby amended by adding thereto a new section which shall read as follows:

15.060 Account for the Acquisition and Improvement of Technology in the Office of the County Assessor. There is hereby created in the county general fund a separate account to be designated as the Account for the Acquisition and Improvement of Technology in the Office of the County Assessor, into which the funds collected in accordance with NRS 361.530 shall be deposited.

The account shall exist for the receipt of those funds and disbursement pursuant to NRS 250.085.
