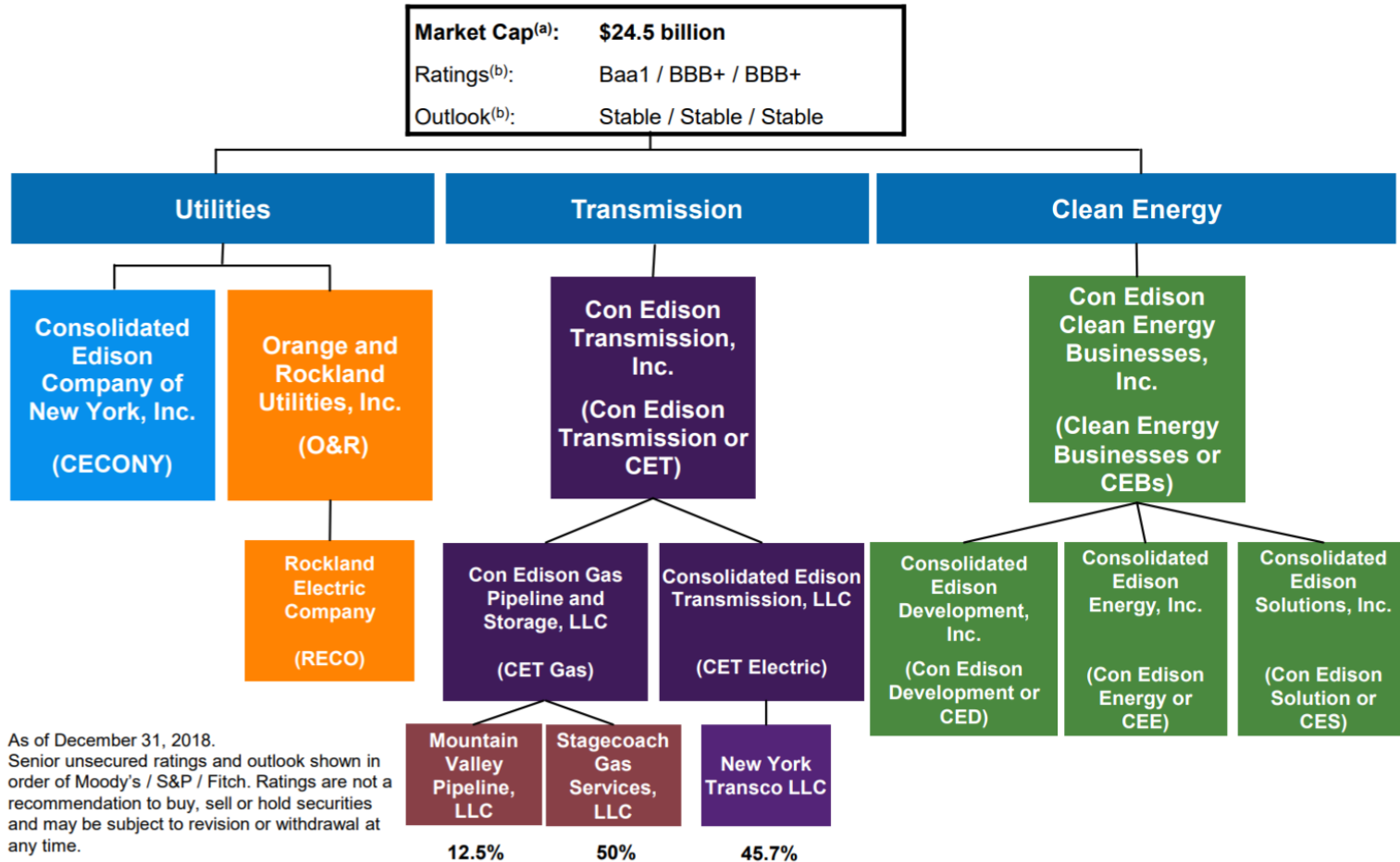

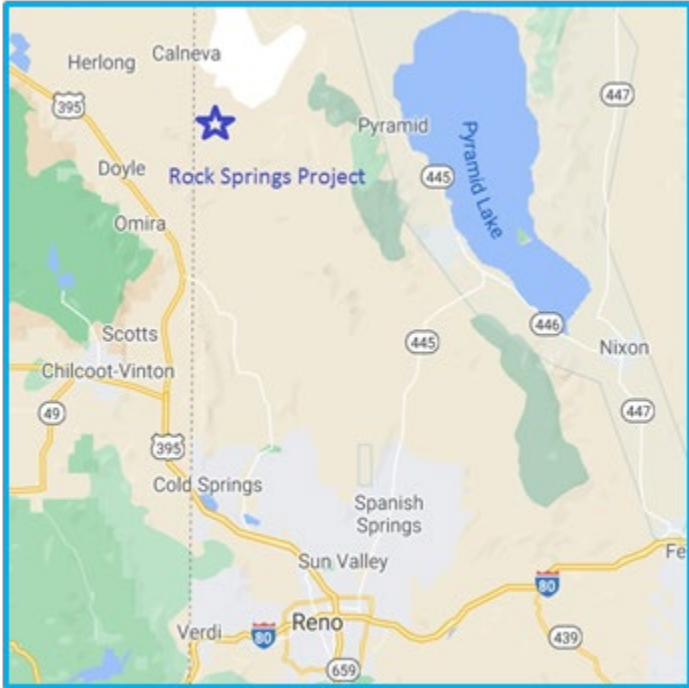

Con Edison Is Among the Nation's Largest Renewable Energy Companies

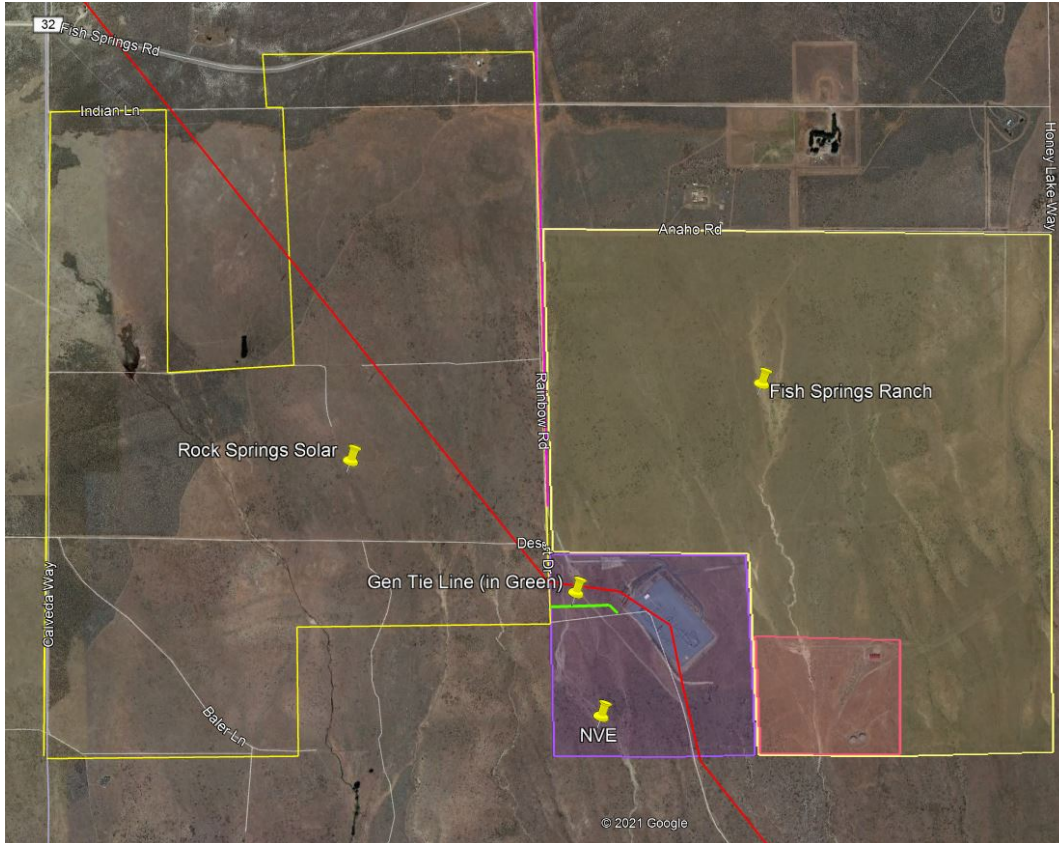
- Almost 3 GW of solar and wind energy projects nationwide
- 100 MW of battery storage installed and operational
- Among the first to develop utility scale solar in Nevada
- Over 900 MW of solar in operation and under development in Nevada
 - Copper Mountain Solar Complex outside Boulder City, Nevada: 700 MW
 - Battle Mountain Solar in Humboldt County, Nevada: 100 MW Solar with a 25 MW Battery Storage System
 - Rock Springs Solar in Washoe County, Nevada: 125 MW of solar with an 84 MW Battery Storage System

Total Capacity	125 MW solar, 84 MW battery storage
Site Control	657 acres under land option with eight (8) landowners

Interconnection	Large Generator Interconnection Agreement with NVE signed 2019 Point of interconnection adjacent to existing NVE Ft Sage Substation.
Anticipated Start of Construction	September 2022



Rock Springs - Project Attributes



- Currently vacant land with some land disturbance due to historical ranching and farming activities
- NVE 345 kV line bisects property and adjacent to NVE substation
- Fish Springs Solar project to the east of the site
- Environmental Statement determined no significant impacts
- Construction water available from Vidler Water 5 miles to the east

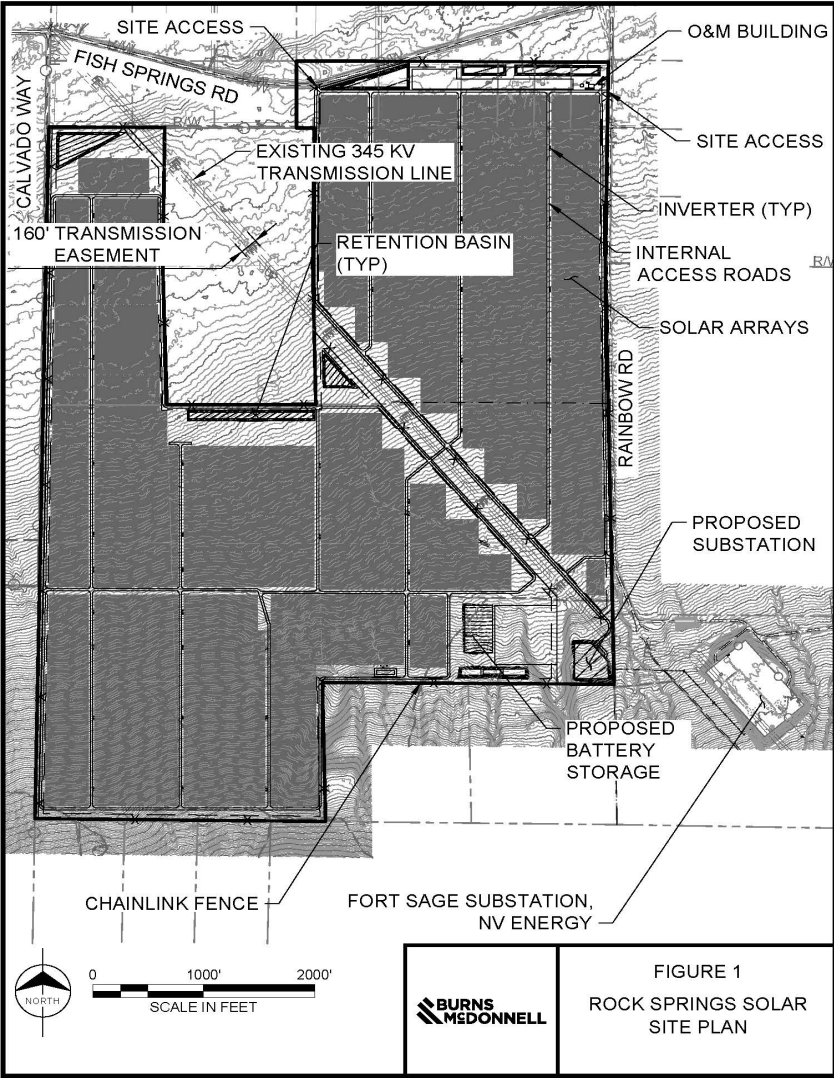

Rock Springs Solar – Proposed Permitting Milestones

Submitted application for Washoe County SUP	January 2021
UEPA Approved	February 2021
Grading/Building and other necessary permits for construction completion	September 2022 *
Construction – mobilization	December 2022
Commercial operation	December 2023

* This date may be extended one year depending upon NV Energy interconnection construction schedule and energy generation needs

Project Benefits

- 150 to 200 construction jobs at peak construction
 - Over 50% must be Nevada residents
- Creation of 5 highly skilled permanent full-time jobs
