Brad Kaneyuki, Regional Street Naming Meeting Coordinator, introduced agenda item 5 a, by stating an application to change the street currently named as Clayton Place to New Deantronics Way, was received by Washoe County GIS on January 22, 2019. Mr. Kaneyuki described the location and explained that GIS had performed a due diligence search of the street directory for duplicate and/or phonetically similar street names. No conflicts were noted. Mr. Kaneyuki referenced the maps included in the agenda packet and stated that all affected properties had been noticed of the proposed street name change by mailing of the RSNC notification letter, with request to appear or submit comments.

No comments or responses were received by the Administrative Assistant.

#### BACKGROUND:

On Wednesday, June 5<sup>th</sup>, 2019, Washoe County GIS received a request from Jon Walker (GIS, City of Sparks) to rename a portion of C ST to AVENUE OF THE OAKS from Victorian Plaza Cir to Pyramid Way. GIS has performed its due diligence by checking the street name against the Master Street Directory for any existing street name duplicates or similar phonetically-sounding street names for the purposes of Emergency Management.

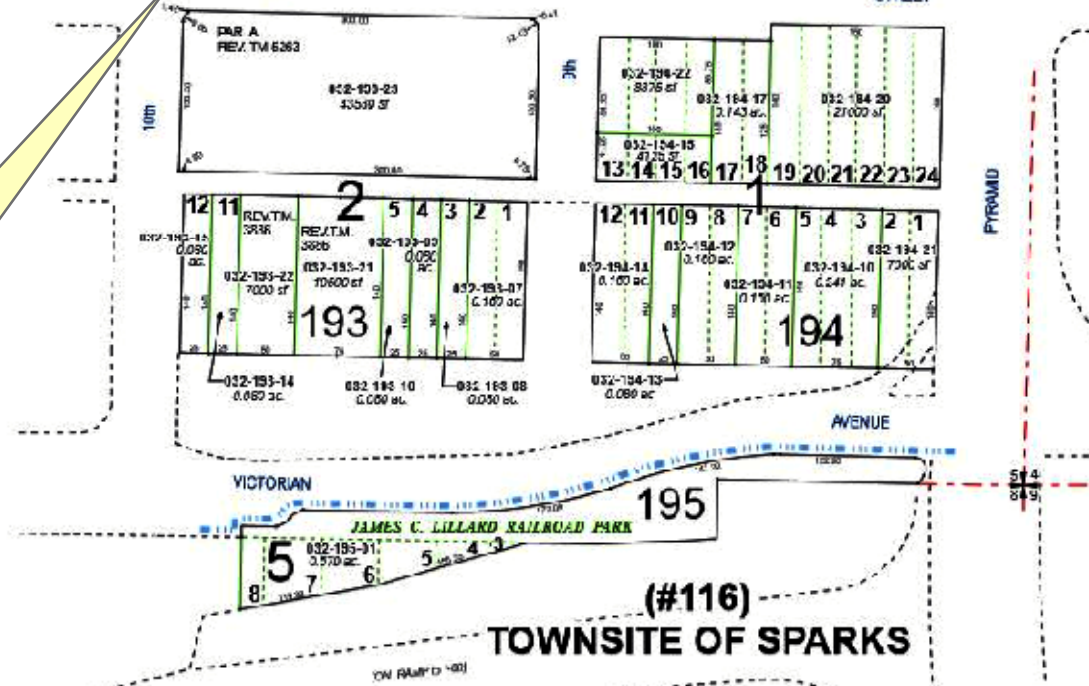
