



# **Brief History**

- City of Reno
  - In 2001, Tiburon was implemented as a new CAD service vendor at Dispatch
    - Washoe Co was also included as an agency partner
  - In 2002, City of Reno Council approved funding for extended services with Tiburon
  - In 2006, City of Reno conducted a significant upgrade
  - In 2008, City of Reno conducted a significant upgrade
  - In 2013, City of Reno conducted a significant upgrade
  - In 2016, City of Sparks joined the regional CAD




# **Tiburon Environment**

- Computer Aided Dispatch (CAD) Fire, Police:

    - Reno hosts and owns primary server/hardware and master contract
  - MobileCOM Police, Fire, Marshals
  - Maverick Mapping & GIS
  - Calculated Routing (2020)
  - EMD/EFD
    - Washoe Co
    - COR (tentative 2020)
  - CAD2CAD (2020)
    - Phase 1: REMSA, Reno Fire
- Records Management System (RMS)
  - RPD, SPD, WCSO
  - NIBRS (Certification, Dec 2019)
- Jail Management
  - WCSO

- Funding availability by each agency
- Lack of IT governance amongst regional partners
- No formalized change management and workflow analysis

- Consistency in Upgrades, Updates




# Reno's Strategy
