PREVIOUS ACTION & BACKGROUND

Washoe County Regional 911 Emergency Response Advisory Committee 5 Year Master Plan stated "A Regional PSAP backup plan should be revisited. The plan should include procedures, technology, and adequate facilities. It should include a backup site design that provides geographic and technical resiliency." Purchasing laptops to operate the remote radio and computer aided dispatch systems, would allow Sparks PSAP to continue operations from remote locations if the Regional Emergency Communications Center were not able to accommodate Sparks staff during an abandonment.
