PREVIOUS ACTION & BACKGROUND

In 2014 and 2019 the E911 board approved funds to purchase headsets for Sparks Police Department Emergency Communications dispatchers. In May 2019 E911 board approved the reimbursement of wireless adapters, headsets, and wired amplifiers.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve request for reimbursement for the purchase of Plantronics equipment used in the operation of the emergency telephone system.
