**SUBJECT:** REQUEST FOR CELLULAR SERVICE FOR MOBILE DATA COMPUTERS (MDC'S) [For possible action] – A review, discussion and possible action to approve, deny or otherwise modify a request to fund/reimburse the costs associated with cellular service to 73 MDC's being operated by Reno Fire Department emergency apparatus for an amount not to exceed \$35,100.00.

**SUMMARY:** REQUEST FOR CELLULAR SERVICE FOR MOBILE DATA COMPUTERS (MDC'S) [For possible action] – A review, discussion and possible action to approve, deny or otherwise modify a request to fund/reimburse the costs associated with cellular service to 73 MDC's being operated by Reno Fire Department emergency apparatus for an amount not to exceed \$35,100.00. This wireless service allows for the receiving and transmitting of incident information between the dispatch and the emergency responder.

**NRS APPLICABLE:** NRS 244A.7645 provides approval of costs associated with maintenance, upgrade, and replacement of equipment necessary for the operation of the enhanced telephone system. In addition this funding would also be in compliance with NRS 244A.7641 (5) (a) & (b).

**STAKEHOLDER REVIEW(s)** Stakeholder are the Public Safety answer Point (PSAP), City of Reno Public Safety Dispatch, City of Reno, Reno Fire Department, Reno.

**FISCAL IMPACT** The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

**RECOMMENDATION** It is recommended that the E911 Emergency Response Advisory Committee approve the request to fund the costs associated with cellular service to 73 MDC's being operated by Reno Fire Department emergency apparatus for an amount not to exceed \$35,100.00.
