Here are some challenges IV/CB residents face.

Our roads

- In town steep and winding roads
- In/out of town IV/CB is limited to three egress roads
- No parking on roads during snow period; minimal parking year round
- Attractions that draw large crowds
 - Vacationers around the lake, estimated at 15M annually
 - Day visitors from Reno and Carson to IV/CB

Summers

- Travel impeded due to road work on highways and other construction, plus much visitor traffic
- Inherent danger of forest fire, coupled with visitors ignorant of the risks

Winters

- Travel impeded by icy road conditions and snow storage
- Difficulties getting a commute workforce into the basin

Numerous concerns are repeatedly raised at CAB meetings.



Evacuation: Washoe County lies in a double-hazard zone for wildfire.



- Two factors that double the wildfire hazard:
 - Tinder-dry plants
 - Increase in atmospheric dryness
- A third factor in some areas... development in wildland-urban interface (WUI)
 - Where the vast majority of wildland fires are caused by people - visitors esp. dangerous

Evacuation: What can Washoe County Commissioners do to reduce our risk?

- 1. Develop a physical movement evacuation plan specific to Incline Village/ Crystal Bay with IV/CB participants.
- 2. Encourage and support infrastructure projects to alleviate the road risks (wider shoulders, more turnouts, no parking on 28, convertible bike path).
- 3. Support a reservation system at Sand Harbor.
- 4. Contribute to the Tahoe Douglas FD project to fund two lake-wide helicopters for rescue and fire fighting.
- 5. Continue to support the Regional Preparedness Program to develop coordination across the north shore.
- 6. Until evacuation risks are understood and planned for, be careful about putting more people into the area with more developments and attractions.
