SUMMARY

The Washoe County Sheriff's Office Operations Bureau has received a donation in the amount of \$1,203.25 to purchase PBTs for use specifically at the Victim Impact Panel meetings to test participants.

BACKGROUND

The Washoe County Sheriff's Office provides deputies (normally reserve deputies) for security purposes at the Victim Impact Panel meetings. These are court mandated meetings for individuals charged with drinking while driving. Deputies conduct breath tests using PBTs to ensure that participants have not been drinking.
