On the advice of legal counsel and to ensure the public has notice of all matters the Safety Committee will consider, the Committee may choose not to respond to public comments, except to correct

factual inaccuracies, ask for County staff action or to ask that a matter be listed on a future agenda. The Committee may do this either during the public comment item or during the following item: "Committee/Staff announcements, requests for information, topics for future agendas and statements relating to items not on the agenda".

# SAFETY COMMITTEE MEETING MINUTES MEETING HELD VIA ZOOM SEPTEMBER 21, 2023

#### 1:30 PM

#### 1. Call to Order and Determination of Quorum [Non-Action Item].

Ben West called the meeting to order at 1:33 pm, read the public participation section of the agenda, and declared they had a quorum.

#### 2. Public Comment [Non-Action Item].

There was no public comment.

#### 3. Announcement [Discussion Only].

Ben West read the agenda item of the resignation of Deputy Christensen from the County Safety Committee and the appointment of Deputy Lesher by the Washoe County Sheriff's Deputies Association to fill the vacancy. Ben added that they are waiting for advice from the District Attorney on a letter from the Deputies Association which Deputy Lesher is working on. This item is to be tabled until the next meeting to officially appoint Deputy Lesher to the Safety Committee.

**4.** Approval of July 20, 2023, Meeting Minutes [For Possible Action]. A review and approval of the Washoe County Safety Committee meeting minutes of July 20, 2023.

Cathy Hill made a motion to approve the minutes of July 20, 2023, as they stand. Jay Slocum seconded the motion. Motion passed unanimously.

5. <u>Presentation and Discussion of Industrial Injury Reports</u> [For Possible Action]. A presentation of the Industrial Injury Summary reports and discussion, and possible action, to make recommendations for the purpose of prevention of work-related injuries or illnesses.

Cathy Hill referred to pages 8, 9 & 10 of the packets and said that while they have been in the process of finding a replacement for Celeste Wallick, they have been playing with some of the reports that come out of the 3<sup>rd</sup> Party Administrator's Worker's Comp system. She found a report that shows not only how many claims are associated with a particular event but also the average cost of the claim which is beneficial for the Committee to see. She added that she is hoping to bring a new style of reports to the Committee in the future and asked members to speak up if there are any requests or recommendations for any type of report that the Committee would find interesting, that can be divulged. Her team will then look into creating the requested reports. Page 10 is still an active list being used that shows claims through August with 78 active open claims of 132 total claims which include the long-term claims that must be maintained.







This number doesn't include claims that were opened and closed in the same time frame that come through Risk Management.

Ben West said that he liked the average cost per claim feature which gives you a better understanding of claims that don't seem like much, but when you see the associated costs and multiply that by the number of claims, you realize its significance.

Cathy noted that some of the claims can be prevented while others cannot. She stressed the importance of continuing to offer videos on how to be cautious and aware, and taking the time to bend properly or to lift properly. She continued that the purpose of this Committee is to avoid injuries at all costs whether through information sharing or training.

Ben West asked if there could be reports created to determine what the most common preventable incidents are. This would help guide them in the outreach they're doing and assist in referring people back to the videos they have. Cathy said they would continue to play with the reports and see if they could find something that could be more informational by the next meeting.

6. <u>Code 65 Update [For Possible Action]</u>. A discussion on Section 65 of the Washoe County Code and possible action to recommend code revisions and/or updates for the purpose of addressing work-related injuries or illnesses.

Ben West stated that this item will be entered into Granicus with the first reading scheduled to go to the Board of County Commissioners on October 10<sup>th</sup> with a tentative second reading for the last BCC meeting in October. Cathy Hill said that this item would extend the time between Safety Committee meetings. Instead of meeting every other month, the Committee would meet quarterly. Ben confirmed that that was one of the significant changes for the Committee but that it also delineated the length of time members are elected to the Safety Committee and more specifics for the Sheriff's office that they alternate between the Deputies Association and the Supervisory Deputies Association. Ben added that Manager Brown reviewed the staff report and said that they need to be able to explain the increases in dollar amount approvals for the different positions within the County which Ben said he is prepared to do.

7. <u>Communication Summary</u> [For Possible Action]. A review, discussion, and possible action based on the communication summary from Ben West for safety announcements to County personnel.

Ben West said that since the last meeting, they had communication about parking lot safety during the Reno Rodeo and Hot August Nights events. They are moving forward with communication on knowing where AED's are located within their workplace as well as first aid kits. He stated that he would like to get a report of most reported injury claims by the next meeting so they can use it as guidance in employee messaging. Cathy Hill recommended more communications regarding the upcoming winter season.

**8.** Award Nominations [For Possible Action]. A discussion and possible recommendations of safety award nominations for County employees.

Cathy Hill thanked Ben West for handling the awards at the BCC meeting. Ben said the employees were surprised and excited to be getting the awards and some didn't even know the awards existed. That was an indication that there needs to be more messaging on the subject through the County Communications Team. Ben added that one employee received their award among their co-workers in their department rather than at the BCC meeting.

9. <u>Committee Planning for 2023 [For Possible Action]</u>. A discussion and possible action regarding activities, events, notifications, and projects to be accomplished in calendar year 2023.

Cathy Hill asked if anything went out regarding Street Vibrations and motorcycle safety. Ben West responded that they have sent communications out on Street Vibrations in the past and would be good to do that again. Ben confirmed that Street Vibrations is the last major event of the season.

Cathy inquired about Building B and if it had reopened yet. Ben said it was not open and not expected to reopen until the middle of October. Ben said he would double check the timing. Cathy asked the committee members if they thought it would be beneficial to reach out to Kevin Dick regarding COVID information since it is beginning to spike again and the upcoming flu season. Members agreed it would be good to send out a reminder.

10. <u>Update on Safety Drills</u> [For Possible Action]. A presentation and update by Ben West on County scheduled safety drills that have taken place since the last meeting and possible discussion of safety drills.

Ben West said there have been no new safety drills. He just got back from a security conference where he attended some trainings on doing table-top type exercises which can be used at certain locations for training in a very short amount of time. This is intended to be used by departments during a regular staff meeting by coming in and doing a 15-20 minute table-top exercise for shelter in place and active shooter types of training. Ben will be meeting with HR in the next couple of weeks to go over this and some other employee training related to workplace violence to try to integrate these table-top exercises in with HR messaging and HR on-line training. Initially, the plan is for Ben to go out and do the table-top trainings himself. And he hopes to have a monthly schedule set up for him to visit departments soon. He noted that he will continue to schedule safety drills moving forward.

Sgt. Lars Christiansen said they have at least two fire drills scheduled at the Washoe County Sheriff's Office focused on detention and fire between November and December and will have some updates on that towards the start of 2024. They are aiming for one of the drills to be on a larger scale and will report back on what they learned from it.

11. <u>Announcements and Future Agendas [For Possible Action]. Comments by the Committee or staff members, limited to announcements, topics, or issues for future agendas. No discussion among committee members will take place on this item.</u>

Cathy Hill stated that the Safety Committee meeting link is not a Teams link, therefore you cannot access the meeting through Teams and to please pay attention to the agenda and join the meetings via Zoom.
