### EXCAVATION PERFORMANCE BOND

KNOW ALL BY THESE PRESENT:

THAT WE, \_\_\_\_\_  
(Name and address of contractor, person, or firm performing street cut work)  
as Principal, hereinafter referred to as "Principal", and \_\_\_\_\_  
(Legal designation or name and address of Surety)  
authorized to do business of surety in the State of Nevada, as Surety and Obligor, hereinafter called  
"Obligor", are held and firmly bound unto the County of Washoe, a Political Subdivision of the State of  
Nevada, as Obligee, hereinafter called "County", in the sum of FIVE THOUSAND DOLLARS and NO CENTS  
(\$5,000.00), lawful money of the United States of America, for which sum, we bind ourselves, our heirs,  
executors, administrators, successors and assigns, jointly and severally, by these presents.

THE CONDITION OF THIS OBLIGATION IS SUCH:

WHEREAS, subsequent to the date of this bond as set forth below, the above bounden Principal will  
apply, and from time to time thereafter during the period this obligation is in force, will again apply to  
the Washoe County Community Services Department for a street cut permit for the excavation,  
backfilling, grading, paving, or performance of repair work in a public street or ally in the unincorporated  
area of the County of Washoe, in accordance with all provisions and requirements of Chapter 85,  
Washoe County Code; and

WHEREAS, Obligor executes this obligation to enable Principal to comply with all provisions and  
requirements of the aforesaid Chapter 85, Washoe County Code;

NOW, THEREFORE, if the above bounden Principal completes all work in accordance with the conditions  
of each street cut permit issued to said Principal under authority of Chapter 85, Washoe County Code,  
during the period this obligation is in force, including all guarantee periods required of said Principal in  
connection with any permit issued pursuant to said Chapter 85, Washoe County Code, then this  
obligation shall be void; otherwise it shall remain in full force and effect.

THIS BOND is executed for the purpose of complying with Chapter 85, Washoe County Code, and shall be in full force and effect as to any street cut permit issues by the Washoe County Community Services Department to Principal or the heirs, executors, administrators, or successors or assigns of Principal, unless and until County receives a ninety (90) day written notice of cancellation from Obligor addressed to the Director of the Washoe County Community Services Department in Reno, Nevada, in which event this obligation shall terminate as to any street cut permit issued subsequent to the termination date ninety (90) days after the receipt of said notice in the Community Services Department.
