As requested during the last Deferred Compensation Committee meeting, the following details provide a review of those Washoe County accountholders that are invested solely within the Voya Fixed Account. The 457 Plan has a total of 1,148 accountholders invested in this manner. The 401a Plan has 84 total accountholders invested in the same manner. These figures differ from those reported in the last quarterly report and I am currently reviewing these differences.

The following details are based upon accountholders as of September 2023 in both the County's 457 Plan and 401a Plan. The breakout of each plan is based upon Voya's commonly used age cohorts.
