- Use your funds at any higher education institution throughout the country, (not just in Nevada), including 2- or 4-year colleges and universities, graduate schools, vocational/technical schools, and qualified career retraining schools. *An eligible institution is one that may participate in the federal financial aid programs.*
- Cover qualified expenses for tuition, fees, certain room and board expenses, books, computers and required supplies.
- Open an account for anyone you chose (child, grandchild, friend, even yourself)
