  - Yellow(July 2023- November 2023) Working with USFWS/BLM- application with USFWS
    - Will provide radio coverage to north of Gerlach, into Sheldon Nation Wildlife refuge
- Greater Reno-Sparks Green field Site (April 2022- October 2022)
  - Cold Springs(4/22-9/22)
    - NVE working power design, working on Special Use Permit Will provide radio coverage along Hwy 395 North
  - Red Peak (2/22-8/22) -
    - working on agreement with Dave Metts
  - Smokey Quartz (9/22-10/23)
    - NVE Working power design, Working with City of Sparks on Administrative review. Will provide radio coverage for city of Sparks around the Pah Rah Interloop, where coverage was limited.
