**SUBJECT:** REQUEST FOR REIMBURSEMENT FOR FUNDING THE THIRD YEAR CONTRACT FOR BODY WORN CAMERAS AND RELATED SUPPLIES [For possible action] – A review, discussion and possible action to recommend that the Board of County Commissioners approve reimbursement (up to \$7,128.00) for the third year contract to continue the agency's body worn camera program.

---

**SUMMARY:**

The 79<sup>th</sup> Nevada Legislature passed Senate Bill 176 (SB 176), which requires uniformed peace officers employed by a law enforcement agency and who were in routine contact with the public to wear a body worn camera (Hereinafter BWC) device effective July 1, 2018. SB 176 expanded the permissible use of the county's 911 telephone line surcharge fund to include the purchase and maintenance of body worn cameras.

The Washoe County Department of Alternative Sentencing was established under NRS 211A in 2005, and is the county's designated law enforcement agency for misdemeanor probation, misdemeanor pretrial, house arrest and drug testing. The Department of Alternative Sentencing employs uniformed Category 1 peace officers to enforce court orders and local, state, and federal laws throughout the community. The Department of Alternative Sentencing supervises a caseload of approximately 2000 people at any given time.

In compliance with the "Washoe County Board of County Commissioners' Policy" adopted January 16, 2018, the City of Reno, City of Sparks and Washoe County have mutually agreed Upon equipment from Axon Enterprise, Inc., to provide body worn cameras for the region. The Washoe County Department of Alternative Sentencing received a quote for body worn cameras And related supplies for use by the Department of Alternative Sentencing from Axon Enterprises on March 19, 2019 and was executed on March 29, 2019. The quote is for five (5) Years for a total of \$41,165.00; the third year of the contract is for \$7,128.00.

The Department of Alternative Sentencing will pay the third year expense of the contract and is

**NRS APPLICABLE:**

NRS 244.7643 and NRS 244A.7645 Provides approval of costs associated use of the county's 911 telephone line surcharge fund to purchase and maintain body worn cameras.

**PREVIOUS ACTION & BACKGROUND**

On January 16, 2018, the BCC adopted the policy of the use of 911 Surcharge Funds for the Body Camera Mandate set forth in Nevada Senate Bill 176.

On January 18, 2018, the Washoe County 911 Emergency Response Advisory Committee Adopted the Five Year Master Plan Update, prepared by the Galena Group Incorporated.

On February 20, 2018, the BCC adopted the Washoe County Regional 911 Emergency Response Advisory Committee Five Year Maser Plan Update, prepared by the Galena Group Incorporated, as recommended by the 911 Emergency Response Advisory Committee.

**FISCAL IMPACT**

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collect to support the emergency reporting system and the funding of body worn cameras for uniformed peace officers employed by a law enforcement agency who routinely interact with the public. Budget authority exists with the E911 Fund to reimburse the Department of Alternative Sentencing for the expense.

The Department of Alternative Sentencing will pay the third year expense of the contract, Effective March 29, 2019, and is requesting the Washoe County 911 Emergency Response Advisory Committee recommend to the Board of County Commissioners to approve Reimbursement to the agency up to \$7,128.00 for the third year contract, in order to continue the agency's body worn camera program.

It is recommended that the E911 Emergency Response Advisory Committee approve the request to recommend to the Board of County Commissioners to approve reimbursement to the Department of Alternative Sentencing up to \$7,128.00 for the third year contract to continue the agency's body worn camera program.
