**PREVIOUS ACTION & BACKGROUND**

Each year the Enhance 911 Fund provides funding for each PSAP to attend training and conferences. Memberships to these organizations provides discounts to these events, access to discounted on-line and in person training courses and other industry specific resources.

**FISCAL IMPACT**

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

**RECOMMENDATION**

It is recommended that the E911 Emergency Response Advisory Committee approve request for funding to purchase NENA and APCO membership for Sparks Emergency PSAP for the combined total of \$3,192. NENA cost, \$1,550. APCO cost, \$1,642.

#### Telecommunicator

Individuals who are certified in, engaged in, employed as, or retired from **non-management and non-supervisory** public safety communications positions, including call-takers and dispatchers, who wish to further their career in the emergency communications industry and support the goals and objectives of NENA.
