On March 17, 2022 the 9-1-1 Emergency Response Advisory Committee approved reimbursement for the City of Reno Public Safety Dispatch for the costs associated with purchasing Plantronics Console Interface Cables, quantity ten (10), for a cost not to exceed \$466.00.

### **FISCAL IMPACT**
