- **SUBJECT:** FUNDING REQUEST PRO-QA PRIORITY DISPATCH FUNDING FOR CITY OF RENO PUBLIC SAFETY DISPATCH PSAP - A review, discussion and possible action to approve, deny or otherwise modify a request for funding for the Reno Public Safety Dispatch for the ProQA-Priority Dispatch Medical Software licensing, training, quality assurance, support and accreditation associated with implementing Emergency Medical Dispatch (EMD) services for a cost not to exceed \$188,051.00.

SUMMARY

FOR PRIMARY PSAP (PUBLIC SAFETY ANSWERING POINT) – CITY OF RENO PUBLIC SAFETY DISPATCH PSAP:

A review, discussion and possible action to approve, deny or otherwise modify a request for funding for the Reno Public Safety Dispatch PSAP for the ProQA-Priority Dispatch Medical Software licensing, training, quality assurance, support and accreditation associated with implementing Emergency Medical Dispatch (EMD) services for a cost not to exceed \$188,051.00.

The City of Reno Public Safety Dispatch PSAP is resubmitting a request to fund procurement and implementation of Emergency Medical Dispatch (EMD) process through ProQA-Priority Dispatch software at the direction of the City of Reno Fire Department and City of Reno City Council (May 2020). This direction aims to ensure that the City of Reno's PSAP will have a more robust method to triage incoming 911 calls in addition to the already established Emergency Fire Dispatch (EFD) protocols; EMD will match service levels currently provided by the Washoe County Emergency Communications PSAP.

Implementation of EMD will support the interoperability and redundancy of the 9-1-1 system within the region by ensuring that Reno Public Safety Dispatch, Washoe County Emergency Communications and REMSA are comparably trained and equipped to support each other in the event of a service disruption or infrastructure incident within the respective PSAPs.

The positive benefits of implementing EMD within the City of Reno Public Safety Dispatch are significant; from improving the 9-1-1 experience of citizens to the appropriate allocation of resources based on the severity and need of each unique incident. This is a significant benefit to the regions continuity of operations that will allow Washoe County Emergency Communications and City of Reno Public Safety PSAP support REMSA, and our citizens, with EMD instruction in the midst of regional critical events, times of high call volume and instances of outages or evacuations.

NRS APPLICABLE:

NRS 244A.7645 Provides approval of costs associated with maintenance, upgrade and replacement of equipment necessary for the operation of the enhanced telephone system.

STAKEHOLDER REVIEW(s)

Stakeholder is a primary Public Safety Answering Point (PSAP) – City of Reno Public Safety Dispatch.

PREVIOUS ACTION&BACKGROUND

Previous actions were taken supporting Washoe County Sheriff's Office PSAP and City of Reno

- 2. September 23, 2021, with approved funding for City of Reno Public Safety Dispatch PSAP – Purchase of International Academy of Emergency Dispatching – Emergency Service Plan for Emergency Fire Dispatching (EFD), in an amount not to exceed \$13,200.
- 3. September 23, 2021, with approved funding for Washoe County Sheriff's Office Communications Center PSAP Purchase of International Academy of Emergency Dispatching Emergency Service Plan for Three Disciplines (police, Fire, and Medical), in an amount not to exceed \$34,560.

FISCAL IMPACT

The Enhanced 9-1-1 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request for funding the costs associated with implementing EMD for the City of Reno Public Safety Dispatch through Pro-QA Priority Dispatch, not to exceed funds of \$ 188,051.00.
