PREVIOUS ACTION & BACKGROUND

On September 23, 2021 the 9-1-1 Emergency Response Advisory Committee approved reimbursement for the City of Reno Public Safety Dispatch for the costs associated with purchasing 24 inch Dell Dispatch Monitors, quantity ten (10), for a cost not to exceed \$1,820.00.

These monitors are to replace existing monitors on CAD workstations and are a vital component of relaying information to first responders from the enhanced telephone system.
