PREVIOUS ACTION BACKGROUND

In the E911 Emergency Response Advisory board meeting July 21, 2022, the Board approved funding to reimburse the County for same/like classes.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system. Budget authority exists within the E911 Fund to the travel and training to the public safety training conferences for registrations, seminars, and meetings.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request to fund/reimburse all costs associated with International Academy of Emergency Dispatching EMD/EPD/EFD call taking on-line training and certification or recertification not to exceed \$1,240.00 total for Washoe County Communications PSAP.
