### **PREVIOUS ACTION & BACKGROUND**

On July 21, 2022 the 9-1-1 Emergency Response Advisory Committee approved reimbursement for Washoe County Sheriff's Office Communications for the costs associated with IAED EFD software recertification for Dispatchers and Supervisors for a cost not to exceed \$7,850.00.

## FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.
