SUBJECT: REQUEST FOR REIMBURSEMENT FOR FLEET CAMERAS, NEW VEHICLES, COSTS NOT TO EXCEED \$5,477.85 [For possible action] – A review, discussion and possible action to approve reimbursement to the City of Sparks for the purchase of two (2) fleet camera systems and related hardware and equipment for two (2) new patrol vehicles, not previously in inventory. Total request not to exceed \$5,477.85.

SUMMARY

The 79th Nevada Legislature passed Senate Bill 176 (SB 176), which requires uniformed peace officers employed by a law enforcement agency and who routinely interact with the public to wear a body worn camera device effective July 1, 2018. SB 176 expanded the permissible use of the county's 911 telephone line surcharge fund to include the purchase and maintenance of body worn cameras.

The City of Sparks through the Sparks Police Department continues to operate the body worn camera and fleet camera systems and is requesting the Washoe County 911 Emergency Response Advisory Committee approve reimbursement to the City of Sparks for the purchase of two (2) new Axon Fleet 3 cameras, related equipment, and installation for two (2) new patrol vehicles.

The City of Sparks through the Sparks Police Department has paid for and received these equipment items and services and is requesting the Washoe County 911 Emergency Response Advisory Committee approve reimbursement to the City of Sparks for this invoice.

NRS APPLICABLE:

NRS 244.7643 and NRS 244A.7645 Provides approval of costs associated to use of the county's 911 telephone line surcharge fund to purchase and maintain body worn and fleet cameras.

STAKEHOLDER REVIEW(s)

Stakeholders are the City of Sparks, Sparks Police Department and Sparks Municipal Court Marshals.

PREVIOUS ACTION & BACKGROUND

On January 16, 2018, the BCC adopted the policy of the Use of 911 Surcharge Funds for the Body Camera Mandate set forth in Nevada Senate Bill 176.

On January 18, 2018, the Washoe County 911 Emergency Response Advisory Committee adopted the Five-Year Master Plan Update, prepared by the Galena Group Incorporated.

On February 20, 2018, the BCC adopted the Washoe County Regional 911 Emergency Response Advisory Committee Five Year Master Plan Update, prepared by the Galena Group Incorporated, as recommended by the 911 Emergency Response Advisory Committee.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system and the funding of body worn and fleet cameras for uniformed peace officers employed by a law enforcement agency who routinely interact with the public. Budget authority exists within the E911 Fund to reimburse the City of Sparks for the expense.

The City of Sparks has paid for and received equipment and services identified in this report and is requesting the Washoe County 911 Emergency Response Advisory Committee approve reimbursement to the City of Sparks up to \$5,477.85 for the purchase of two (2) new fleet camera systems, related equipment, and installation in two (2) new patrol vehicles, not previously in inventory.

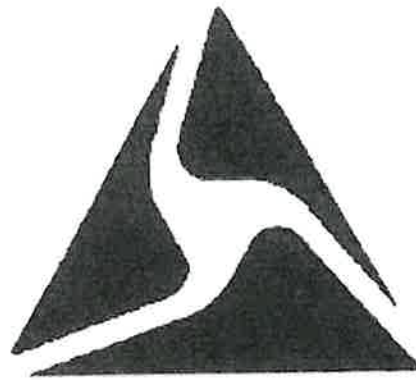

Recommendation: Staff recommends City Council authorize the expenditure of \$647,502.93 to purchase twelve vehicles from Champion Chevrolet.

Financial Impact: \$647,502.93. \$2,526,160.00 was approved for FY2022 Motor Vehicle Fund 1702 and \$1,657,762.22 of budget authority is currently available. \$41,500 was approved for 21-7500L in FY2021 Motor Vehicle Fund 1702 and is currently available. 12 vehicles from Champion Chevrolet will cost of \$647,502.93.

Agenda Item Brief: Public Works Maintenance is requesting City Council approval to expend \$647,502.93 to purchase twelve vehicles from Champion Chevrolet utilizing State of Nevada Contract 99SWC-S1495.

Background:

Public Works Maintenance is seeking City Council approval to purchase twelve vehicles from Champion Chevrolet for \$647,502.93. The proposed vehicle purchases are included in the City's approved Capital Improvements Plan (CIP). Eleven of the requested vehicles are to replace vehicles in the City fleet, including eight Police Department vehicles, two Fire Department vehicles, and one for the Municipal Court. The twelfth vehicle is requested as a spare unit for the Police Department so there is a ready replacement when a current patrol unit is out of service, eliminating the current extended wait time for a replacement.

The replacement vehicles are as follows: 2220 22-7500A replaces Unit 2305; 2426 22-7500B replaces Unit 2306; 2427 22-7500C replaces Unit 2402; 2428 22-7500D replaces Unit 2406; 2429 22-7500E replaces Unit 2408; 2430 22-7500F replaces Unit 2413; 2155 22-7500J replaces Unit 2403; 2156 22-7500K replaces Unit 2404; 2499 22-7500L replaces 9F; 3011 22-7500M replaces Unit 321A; and 3012 22-7500N replaces Unit 313B.

Analysis:

Of the total cost of \$647,502.93, \$41,500.00 was approved to purchase a replacement vehicle for police patrol in FY21. However, a replacement vehicle was not available last fiscal year. The remaining \$606,002.93 for this proposed purchase is included in the FY 2022 CIP, Fleet Replacement Fund (Fund 1702), which has a current balance of \$1,657,762.22.

If City Council approves this expenditure, the City will use State of Nevada Contract 99SWC-S1495 to source the equipment from Champion Chevrolet.

Alternatives:

1. City Council may approve the purchases as recommended by staff.
2. City Council may reject the purchases and provide direction to the City Manager.

Recommended Motion:

I move to authorize the purchase of twelve vehicles from Champion Chevrolet for \$647,502.93 utilizing State of Nevada Contract 99SWC-S1495.


