PREVIOUS ACTION & BACKGROUND

On January 16, 2020, the E-911 Board approved the purchase of four (4) Harris Symphony Radio Workstations for Sparks Police PSAP. There are 4 speakers at each station.

FISCAL IMPACT

The Enhanced 9-1-1 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.


