SUMMARY

PUBLIC SAFETY TRAINING CONFERENCE FOR PRIMARY PSAP (Public Safety Answering Point) WASHOE COUNTY SHERIFF'S OFFICE COMMUNICATIONS:

A review, discussion and possible action to approve, deny or otherwise modify a request to fund/reimburse for the costs associated with traveling to and attending the National Emergency Number Association (NENA) conference '9-1-1 Goes to Washington' for two attendees. The 2024 NENA Conference is being held in Washington, DC. Conference registration for each attendee is \$460.00. The airfare for each attendee roundtrip is estimated at \$450.00. Each attendee per diem is estimated at \$600.00. Lodging for each attendee will be estimated to be \$2900. Total cost estimated in an amount not to exceed \$8820.00 for both attendees and \$4410.00 for one attendee.

NRS APPLICABLE:

NRS 244A.7645 Provides approval of costs associated with maintenance, upgrade, and replacement of equipment necessary for the operation of the enhanced telephone system.

STAKEHOLDER REVIEW(s)

Stakeholder is a primary Public Safety Answering Points (PSAP) – Washoe County Sheriff's Office Communications.

PREVIOUS ACTION BACKGROUND

On May 18th, 2023, the 9-1-1 Emergency Response Advisory Committee approved funding for the City of Reno Public Safety Dispatch for the costs associated with sending two (2) attendees to the 2023 NENA Conference in Grapevine Texas for a total cost not to exceed \$5,500.00.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system. Budget authority exists within the E911 Fund to the travel and training to the public safety training conferences for registrations, seminars, and meetings.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request to fund/reimburse all costs associated with traveling to and attending the National Emergency Number Association (NENA) conference '9-1-1 Goes to Washington' for total cost estimated in an amount not to exceed \$8820.00 for both attendees and \$4410.00 for one for Washoe County Communications PSAP.
