**E.** Proposed change to online e-check amount accepted (For Possible Action) – A review, discussion and possible action to modify currently established e-check amount accepted online from \$100,000 to \$1 million; and, authorize staff to enact change with vendors.

Currently, citizens are able to pay online by e-check for any amount up to \$100,000. City of Reno has requested that the amount be increased to allow payments made by e-check for any amount up to \$1 million. It was unknown how the current limit had been selected.

Daniela Monteiro, City of Reno, moved to increase the e-check limit from \$100,000 to one million dollars. Erin Dixon, Washoe County Health District, provided the second. There was no response to the call for public comment or Committee discussion. Upon a call for a vote, the motion carried unanimously.
